

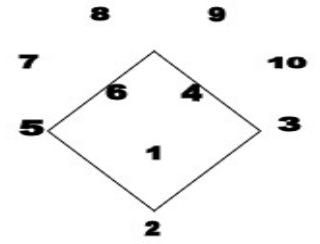

I, the undersigned, fully understand that my participation in the game of softball in the City of **Rancho Cucamonga** (hereinafter referred to as "CITY") is a dangerous activity that exposes me to the risk of personal injury, illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19, as well as death and damage to my property. I hereby acknowledge that I am voluntarily participating in this activity and agree to assume any such risks. I hereby release, discharge, and agree not to sue the CITY and Major League Softball, Inc. (hereafter referred to as "MLS"), for any injury, death, or damage to or loss of personal property arising out of, or in connection with, my participation in this activity from whatever cause, including the active or passive negligence of the CITY and/or MLS, or any other participants in this activity. I hereby agree to assume any and all such risks. In consideration for being permitted to participate in the CITY's Adult Softball Program, I hereby agree for myself, my heirs, administrators, executors, and assigns to release, waive, hold harmless and indemnify MLS, its officers, employees, agents, representatives, umpires, scorekeepers, and volunteers, as well as the CITY, its elected officials, members of Boards and Commissions, officers, employees, agents, representatives, and volunteers from any and all liability, claims, demands, and actions for any injury, illness, expense, death or damage to personal property arising out of or in connection with my participation in the Adult Softball Program from whatever the cause, including but not limited to, those enumerated in the California Government Code, the active or passive negligence of MLS, or the CITY, and either parties' officers, employees, agents, representatives, umpires, scorekeepers, or volunteers.

I have carefully read this release, hold harmless, and indemnity agreement and fully understand its contents. I understand that it is a full release of all liability and sign it of my own free will. I the undersigned, also understand that I must sign this agreement prior to my participation in the Adult Softball Program.
